The Provincial Proficiency Scale

Scales have always been used in BC assessment and reporting, primarily in elementary grades. However, there have been a variety of scales in use for reporting. The policy update will unify all schools and districts to a consistent, four-point Provincial Proficiency Scale to communicate student learning in grades K-9.

Benefits of the Scale

- · Views learning as ongoing, rather than signaling that learning is done
- Values growth and most recent evidence of learning
- · Provides feedback, to both families and students, on where the student is at and how to help them move forward in their learning
- Supports lifelong learning by shifting the focus to developing competencies rather than the achievement of marks
- Maintains high provincial standards by focusing on helping all students attain proficiency in their learning
- Is inclusive of all learners by focusing on strengths and next steps for each individual learner

K-12 Reporting Policy Framework Launched in 2023-24

The Ministry of Education and Child Care has updated its reporting policy for students in all grades. Schools across the province must implement the changes in the 2023-24 school year. This will impact aspects of how all schools report learning to students and families. What's new and what remains the same is outlined below.

What is staying the same?

- Letter grades and percentages for Grades 10 to 12
- Five communications of student learning to families: three report cards and two communications of flexible format such as, for example, parent-teacher conferences
- Written descriptive feedback to accompany reports for all grades

What is changing?

- · For students in Kindergarten to Grade 9, all school districts in BC will use the Provincial Proficiency Scale and not letter grades or percentages
- A graduation status update for Grades 10-12 on students' end of year report card
- In all grades, students will do a self-assessment of the <u>Core Competencies</u> that are part of the BC curriculum, as well as student goal setting in the three written reports


What is now required by the Ministry's new policy that families may already have noticed?

Feeding Futures



What is the Feeding Futures Fund?

The Government of British Columbia announced a **Feeding Futures Fund** on April 4, 2023 to support the building, developing and expanding of local school food programs.

The 2023-24 school year is intended to be an implementation year.



District Plan



Four Part Plan

1. Expand the current Elementary School Meals Program. This program is a voluntary, fee for service option with partially and fully subsidized plans. This would increase the total number of elementary schools with a meal program from the current 12 to 18.



2. Supply targeted meals to elementary schools with students identified in need of additional support for food security. Currently, this includes students at 6 schools.



3. In all secondary schools, provide students identified in need of additional support for food security with cafeteria meal cards – for breakfast and lunch.



4. Allocate Feeding Futures Fund to the remainder of elementary schools to support the individual needs of students identified in need of additional support for food security. These funds can be used to subsidize program-based meal programs, PAC hot lunches, snack packs, cold lunch options, frozen lunch options, food cards, and food services for all identified students.



This plan will be reviewed and adjusted as the year progresses based on input by schools, students, parents and the community.

Capital funding is being requested to support the infrastructure necessary to expand food services to students.



How Can Support be Accessed?

Currently, schools are using a variety of methods to communicate and/or identify students with food security needs. These include sharing information through PACs and with Newsletters, students and/or families self identifying, information from community groups and agencies, and information from teachers, counsellors and other school staff.

The District will be developing a survey for parents to ensure students who require food security are receiving the support.

The Accessible British Columbia <u>Act</u>

The Accessible British Columbia Act came into effect September 1, 2022. It applies to organizations including school districts and independent schools as of September 1, 2023.



What are the Objectives of the Act?

The Act aims to increase all persons' ability to meaningfully participate in their communities by attempting to remove barriers through the development of accessibility standards. To do so, the Act requires certain organizations, including school districts and independent schools, to make their organizations more accessible.

Key objectives are:

Increase meaningful participation in communities (including in schools)


Develop standards for improved services delivery in areas such as education

Harmonize with other jurisdictions, including federal requirements



Compliance requirement

The Accessibility BC Act mandates that provincial school districts and independent schools must develop by September 1, 2023:


